Fiscal Year 2022- Current status

- No President's Detailed Budget
- Community Project Funding Requests have complicated the process
- Association Targets for Additional Dredging Needs- We are asking for \$75 million each.
 - Inland Waterways- \$60 million allocated in FY21
 - Small, Remote or Subsistence Navigation-\$65 million in FY21
 - Navigation-\$40.156 million in FY21)
 - TOTAL FY21- \$165.2M



AIWW/IWW Needs Assessment 2021 Update

- WRRDA 2014 requires Corps of Engineers to quantify annual maintenance dredging needs of AIWW/IWW and provide report to Congress.
- 2021 estimate is \$81.591M to return to authorized width and depth (2016 estimate was \$126M). NC is \$18M.
- Annual Maintenance estimate is \$49.5M (2016 estimate was \$50.2M). NC is \$12M.
- Maintenance dredging projects conducted or planned in every state from VA to FL in FY21.

FY21 Projects for NC

- 1. AIWW North Contract with areas to dredge including:
- Two areas in Core Creek (Upland Disposal) (240,000 CY Total)
- Brown Inlet Crossing (Material to be placed on Onslow Beach) (50,000 CY)
- Topsail Creek and Howard Creek Crossings (Material to be placed on Topsail Beach) (70,000 CY)
- 2. AIWW South Contract with a scope to include:
- Mason's Inlet Crossing (Upland Disposal) (25,000 CY)
 - Non-Federal Funding
- Lockwoods Folly Inlet Crossing and Widener (Material to be placed on Oak Island) (193,000 CY)
 - Federal and Non-Federal Funding
- Shallotte River Crossing (Material to be placed on Ocean Isle Beach) (45,000 CY)
- Shallotte Inlet Crossing (Material to be placed on Ocean Isle Beach) (105,000 CY)

Moving forward!

- Continue to support Administration Budgeting and Congressional Funding Pot Appropriations for Waterway with Congressional Delegations. Continue House of Reps. bi-partisan delegation letter.
- Watch and engage the process for Community Project Funding
- Extend outreach and partnering along Marine Highway 95 and the Atlantic seaboard. Meet new "friends" in Congress.
- Remain engaged on execution of FY21 Funding.
