#### What We Do on the Resilience Team

- 1. Advise State decision makers on recovery and resiliency activities, and establish North Carolina as a national leader in integrative, cross-sector resilience planning and practices
- 2. Lead and coordinate resiliency efforts across State and federal agencies, regional and local governments, higher education, and other public and private stakeholders
- 3. **Provide expertise, technical support, and capacity building** to communities for resiliency planning and projects to protect communities from flooding and other natural disasters








#### What does RESILIENCE mean?

A state where our communities, economies, and ecosystems are better able to rebound, positively adapt to, and thrive amid changing conditions and challenges, including disasters and climate change.








# New Challenges Need New Solutions

Facilitating a community-driven process for setting coastal resilience goals, assessing local capacity, and identifying and prioritizing projects.

Helping plan and implement resilience initiatives in the North Carolina census tracts most at risk to natural hazards and climate change.












# Regions Innovating for Strong Economies and Environment (RISE)


- Served nine regions in Eastern NC impacted by Hurricane Florence






